## TOWN OF SHERMAN MONTHLY BOARD MEETING May 15, 2018

Chairman Daniel J. Fedderly called the May 15, 2018 Monthly Board Meeting to order at 5:30 p.m. at the Sherman Town Hall and noted the meeting had been properly published and noticed.
